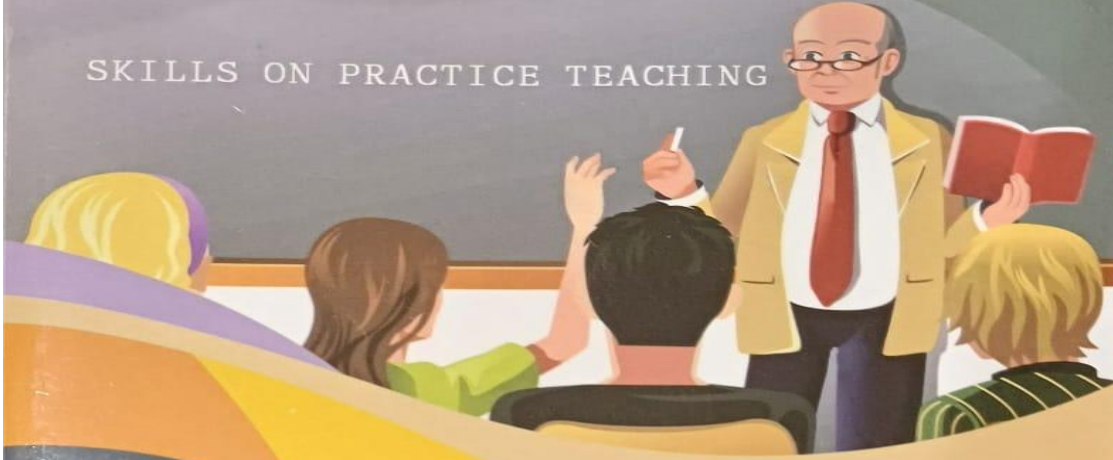

### Abstract:

*The objective of the present study was to find out whether there is any significant difference of job satisfaction of the male and female secondary school teachers and also to compare whether there is any significant difference of job satisfaction of the govt. and private secondary school teachers. Descriptive survey method was used for the present study. 100 teachers from private schools and 100 teachers from govt. schools were considered as sample from the present study. Stratified random technique was used in order to collect the relevant data. Here the investigator used Job satisfaction inventory (R.S. Mishra, 1993) and General information schedule. The findings of the present study found that the male teacher of secondary school has high job satisfaction than female teacher. Thus from the result it can be said that job satisfaction of secondary school teachers differed significantly depending on their gender. Again the study found that there were significant difference between the govt. secondary school teacher and private secondary school teacher. From the result the investigator found that govt. teacher have high job satisfaction than the private teacher.*

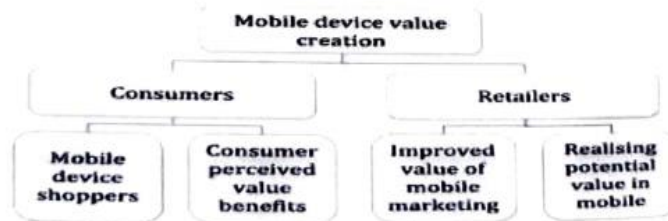


Fig. 1. Discussion topology.
